

## Charles L. and Anna N. Gault Scholarship

Application for Financial Assistance for 2020-2021 School Year

**Deadline:** March 31, 2020

The 2020-2021 Scholarship Application must be completed and postmarked with the following attachments by March 31, 2020 in order to be considered for the upcoming school year. If you do not have all the requirements attached, your application will not be reviewed. *No courtesy calls will be made in the instance of incomplete applications.* Please complete all fields on this application, even if you are reapplying for the scholarship. Please feel free to send your application by certified mail to confirm it is received by the due date, or you may call to confirm. If you drop your application off in person you may ask for a receipt.

### Your application must include:

- **A copy of your household's most recent annual income**  
This must be from the person who claimed the student or the student's return. This can be provided from their 1040 or the student's completed FAFSA (Free Application for Federal Student Aid Form).
- **A copy of fall/winter 2019 grades**  
We do not require an official transcript, but it is imperative that your full name and your cumulative G.P.A. are included on the grade report submitted. A separate copy of your grades is required for this application. If you have submitted your grades for another purpose do not assume they will be included for this application.
- **Two (2) reference letters.**  
These may be mailed separately to the Trust Department, as long as they are received by March 31st
- **A brief essay on: (1-2 paragraphs)**  
"What's the most difficult educational challenge you have ever faced? How did you handle it?" *This is required by all applicants.*

## Criteria | Charles L. and Anna N. Gault Scholarship

Under the provisions of this trust, the following criteria has been established.

1. Preferably members in good standing of South Parkersburg United Methodist Church or members in good standing of a church of the United Methodist faith situated in either Wood or Wirt Counties, West Virginia.
2. Students shall be residents of Wood or Wirt Counties, West Virginia.
3. Recipients must be selected on the basis of need, good character, and reputation, but academic ability and desire should also be considered.
4. Students must obtain reference letters from school teachers or counselors.
5. All recipients must be graduating seniors of a Wirt or Wood County high school.
6. All recipients must continue to be a student in good standing and shall not fail to maintain a 2.0 G.P.A.
7. Prior to awarding any additional funds to a recipient who has previously been awarded a grant, the Trustee shall obtain a report from the institution in which the student was last enrolled as to the student's grades and the work being done by the student. In addition, it is the duty of the student to communicate with the Trustee at least once a semester concerning the course of study being pursued and to furnish the Trustee with a transcript that includes the full name of the student and the cumulative G.P.A.
8. No award shall be automatically made to any individual who has previously received a grant.
9. All applications must be filed on forms provided by Trustee. Applications for the fall semester of the current year should be submitted by the deadline stated on the application. However, the Trustee may, at its discretion, consider applications submitted after this date.

10. It should be emphasized that this fund is designed to assist worthy students.
11. Recipients of grants shall receive the amount awarded at the beginning of the fall semester and at the beginning of the spring semester, assuming the G.P.A. and other criteria have been established during the first semester.
